

PRIVACY NOTICE

In accordance with the provisions of the "Federal Law on the Protection of Personal Data Held by Private Parties," its Regulations, and other applicable regulations, "Blue Energy and Electricity, S.A.P.I. de C.V." hereby declares that it is a company duly incorporated under the laws of Mexico, with registered office at Montes Urales 754, Office 101, Colonia Lomas de Chapultepec, Miguel Hidalgo Municipality, Zip Code 11000, Mexico City, and, as the party responsible for the processing of your personal data, hereby informs you that our clients' information is handled in a strictly confidential manner. Therefore, by providing your personal data, including but not limited to:

- 1. Full name of the Client and/or legal representative, as well as contacts indicated in the Electric Power Supply Agreement,
- 2. Address and/or domicile,
- 3. Federal Taxpayer Registration (RFC) and/or tax certificate,
- 4. Office, personal and/or mobile phone numbers,
- 5. Email address,

Such data shall be used solely and exclusively for the following purposes:

- 1. Information management and provision of the Electric Power Supply Service,
- 2. Updating the Client Database,
- 3. Any analogous or compatible purposes related to the above.

In the case of sensitive data, such as:

- Financial Data: income, bank statements, and other related data.
- 2. Asset Data: tangible property, real estate, and other related data,
- 3. Where applicable, family or non-family references: name, address, phone number, relationship, etc.,

These will be used solely and exclusively for the following purposes:

 Investigation and/or acquisition of Performance Guarantees related to payment obligations arising from Supply Agreements,

- 2. Information management and provision of the Electric Power Supply Service,
- 3. Any analogous or compatible purposes related to the above.

To prevent unauthorized access to your personal data and ensure that the information is used solely for the purposes stated in this Privacy Notice, we have established various internal procedures designed to avoid unauthorized use or disclosure of such data, thereby allowing us to handle them appropriately. These obligations are also mandatory and binding for all personnel and affiliates of Blue Energy and Electricity, S.A.P.I. de C.V.

Furthermore, we inform you that your personal data may be transferred and processed by individuals or entities other than this company. All personal data are processed in accordance with the applicable and current laws of the country. Accordingly, we inform you that you have, at all times, the rights of Access, Rectification, Cancellation, and Opposition (ARCO Rights) concerning the processing of your personal data. Blue Energy and Electricity, S.A.P.I. de C.V. shall be responsible for obtaining prior written consent from its own employees concerning the processing of personal data derived from information that clients may provide due to the company's access to their facilities in order to provide the Electric Power Supply Service.

Please note that, for certain purposes, revocation of consent may result in Blue Energy and Electricity, S.A.P.I. de C.V. being unable to continue providing the Electric Power Supply Service.
